# **Petition to Save Waldingfield**

55 Waldingfield and its road hold a great deal of history dating back nearly 400 years, and it is deeply embedded in the fiber of our community. The property is now at risk of becoming a corporate complex, so will you please consider the following alarming, detrimental impacts to the community:

- the proposed corporate office complex irrevocably threatens to degrade the character of this designated Scenic Road;
- the agrarian nature of the area, which is zoned as rural residential, is not compatible with a large office development;
- the traffic impacts are identified as "significant" and not amenable to reasonable mitigation;
- the increased traffic volume poses additional safety risks to non-vehicular users of the Road;
- a four-phase development is proposed, and applicant refuses to commit to limiting expansion;
- the development is located on the banks of the endangered Ipswich River and could further harm it;
- the applicant refuses to commit to a Conservation Restriction on an important viewshed area;
- there is an absence of planning scenarios to understand best to worst case set of conditions and associated impact mitigation plans;
- nothing in the Great Estates Preservation Bylaw remotely suggests that its intent was to protect historic, great estates at the expense of historic scenic roads;
- the Planning Board is responsible for protecting the zoning districts and must determine that the benefits to the neighborhood exceed the zoning protections to approve the permit this is clearly not the case.

We, the undersigned, are concerned Ipswich citizens who urge our Planning Board Members and Town Leaders to act now to deny Ora, Inc. approval of their proposed development. We are grateful for your consideration and time
